**MINUTES FOR THE REGULAR MEETING ON MONDAY, JULY 29, 2024,  
BEGINNING AT 10:00 A.M. IN THE CONFERENCE ROOM OF THE PUBLIC WORKS  
BUILDING, 1834 EAST MAIN STREET, QUINCY, CA 95971**

1. Ms. Graham called the meeting to order at 10:00 am and took roll call. Present: Faith Strailey, John Forno, and Jeff Engle.
2. The following members of the public were present: Ricky Ross from InterMountain Disposal, Lisa Lester from Feather River Disposal. The following Public Works staff were present: Sean Graham, solid Waste Program Manager.
3. Graham opened the meeting for public comment: Lester mentioned that customers in the lake Almanor area are complaining regarding delays in their service due to construction on A-13.  
Ross mentioned that he had been contacted by Cal-Fire staff, offering to loan an Air-Curtain burner to the County for use in green waste disposal.
4. Engle motioned to approve the minutes from the PCIWMTF meeting of May 6<sup>th</sup>, 2024, Strailey seconds the motion, all voting members vote to approve the draft minutes.

5. Graham opened the meeting to discussion of necessary repairs at the East Quincy Transfer Station. Graham explained that several support columns had sustained damage from Feather River Disposal staff. Lester explained that the matter had been forwarded to FRD's insurance.
6. Graham opens the meeting to discussion regarding the 2024 Plumas County Grand Jury Report on Solid Waste and Recycling. Graham explained that the report discussed the need for more CRV recycling options as well as greater recycling education. Lester explained that FRD has recently prepared an educational mailer to help inform customers regarding recycling information. Strailey indicated that she would like to see more information regarding the different plastic numbers.
7. Graham opened the meeting to discussion of Franchise Contractor complaints and comments. Lester acknowledged that there had been confusion and frustration from customers regarding weather delays. Ross explained that there had been complaints regarding missed pickups, however Ross indicated that many of these customers had not put their cans out in time. Graham asked if the franchise contract dictates what time cans have to be out, Lester explains that the Franchise contract dictates that cans have to be out at 7:00 am.
8. Graham confirmed that the next SWTF meeting will be held on January 28, 2025. Forno motioned to adjourn, Strailey seconded the motion and all present members voted in favor.
