- C. Present Progress Report from Plumas Crisis Intervention and Resource Center (PCIRC) related to Navigation Center Program; discussion.
 - a. *Attachment(s): PCIRC Progress Report*

PCIRC was asked to provide a progress report on the Northstar Navigation Center, included in the packet that was sent to CCP Members. Probation has made multiple referrals and has a client who saw great success, due in part to the navigation center services.

Cathy Rahmeyer of PCIRC mentions that the report should have denoted it was for Q3, not Q2 as listed, and that two clients referred to the program were unsuccessful.

David Hollister inquires as to whether the clients are PRCS or Formal Probation clients, to which Chief Allred replies that the clients referred are a mix of both.

Cathy Rahmeyer mentions that since the program had a late start, there will be cost savings in their CCP budget.

David Hollister mentions that the copy of the agenda he has states there were 4 RFP received. Miguel Herrera of Probation acknowledges that it may have been a previous revision of the agenda that was printed out, and that 5 RFPs were received. A motion to accept them is presented.

E. Development of a Proposed CCP Budget for Fiscal Year 2025-2026; discussion and possible action.

a. Attachment(s): See Requests for Funding

Chief Allred states that at the start of FY24.25, a carry-over budget was implemented as a measure to ensure continuity of service while further information on funding was received from the state. Miguel Herrera mentions that current trends show that base funds should remain close to what was received for FY24.25, and that minimal growth will be received for FY24.25, which is still an improvement over the lack of growth funds for FY23.24.

Chief Allred asks the committee if they should wait until further information from the state is received before making budget decisions. Fund balance figures for the start of FY25.26 will depend on how much funding is returned at the end of the year. David Hollister asks about the CCP Bylaws, namely in regard to requirements surrounding a 4/5ths vote to approve certain things, such as the budget. If a supermajority is required, the budget would need to be approved before the current Sheriff retires. Chief Allred mentions he will look into the requirements.

David Hollister suggests that another meeting be held regarding the budget, given the base award for Plumas is around 1,086,000.00, and at some point, talks will need to be held about the Sheriff’s office having to justify having 60% of that base awarded to them annually, which may not be in line with what the CCP was created for. Chief Allred states that he does not disagree, and that such a small budget leaves little room for other opportunities.

Sharon Sousa brings up a topic, stating that the Behavioral Health agency had not received prior CCP funds, due to an error. Sharon Sousa states that this affects the rollover funds, to which David Hollister replies that a discussion should be held regarding the funds given and that unspent monies are typically rolled back into the county CCP fund and are then budgeted for in the upcoming year. Chief Allred questions: Should the correction proceed as planned, or should the CCP act on the matter? Chief Allred states he is unsure whether intervention is appropriate or not.

Sharon Sousa mentions that it should be discussed, as it might affect the way the budget is thought about. After further conversation, it was agreed by all that the matter should be agendaized for a future meeting.
